Dear Ms. Bayo:

Verizon Florida LLC ("Verizon") hereby respectfully notifies the Florida Public Service Commission (the "Commission") of the name change of Verizon Florida Inc. to Verizon Florida LLC (the "Name Change"). This name change reflects the company's conversion from a corporation to a limited liability company.

Verizon requests that the Commission change the certificates of public convenience and necessity held by Verizon Florida Inc. to reflect the Name Change to "Verizon Florida LLC." Verizon will file revised tariff sheets as appropriate in connection with the Name Change. These tariff changes will not revise the rates, terms or conditions of any services currently offered. Verizon amended its qualification documents in Florida on November 15, 2006 to accomplish the Name Change.

Verizon will continue to provide telecommunications services in Florida and the Name Change will have no impact on customers or services. Customers will be provided notice of the Name Change via a message on their bill.

Verizon respectfully submits that the public interest, convenience, and necessity would be furthered by the Name Change. Further information regarding the Name Change is available at the request of the Commission.
