Gentlemen:

This firm represents Venice Jet Center, LLC, located in Venice, Florida. I have been asked to help solve the problem of why Verizon has failed to change the name on the telephone account to Venice Jet Center, LLC. It is frustrating to try to do business with a company where you cannot speak to a live person, or if you do, that person cannot help you and simply refers you to someone else who cannot help you.

Venice Jet Center has been trying since June to get the account name changed from Triple Diamond Jet Center to Venice Jet Center. 

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the payment of the sum of Ten Dollars (\$10.00) to TRIPLE DIAMOND JET CENTER, L.L.C., a Florida limited liability company (herein "TRIPLE DIAMOND"), and other good and valuable considerations, the receipt of which is hereby acknowledged by TRIPLE DIAMOND, TRIPLE DIAMOND does hereby assign, transfer and deliver unto VENICE JET CENTER, L.L.C., a Florida limited liability company (herein "VENICE JET CENTER"), the following intangible assets:

(a) Any right or interest in the term "Jet Center" as same is used by TRIPLE DIAMOND in the operation of its business at Venice Airport.
