

**BELLSOUTH'S MOTION FOR EXTENSION OF TIME**

BellSouth Telecommunications, Inc. ("BellSouth") asks the Florida Public Service Commission ("Commission") for an extension of time in which to file its response to the Complaint ("Complaint") filed by Lennar Homes, Inc. ("Lennar"). In support of this Motion, BellSouth states the following:

1. On or about November 7, 2006, Lennar filed their Complaint against BellSouth for its alleged failure to provide services in accordance with Section 364.025(1), Florida Statutes.
2. In accordance with Commission Rules, BellSouth's response to the Complaint is due on November 27, 2006.
3. BellSouth requires more time to review and prepare an appropriate response to the Complaint.
4. BellSouth seeks through and including December 1, 2006 to file a response to the Complaint.
5. No party would be negatively impacted by the Commission granting BellSouth's requested extension. Further, there is no procedural schedule in place to be impacted.
6. BellSouth contacted Lennar and Lennar does not object to the extension.

WHEREFORE, for the foregoing reasons, BellSouth respectfully requests an extension of time through and including December 1, 2006 in which to file its response to the Complaint.


