CLOSURE OF DOCKET

In Order No. PSC-05-0734-PAA-TP, issued July 8, 2005, the Commission accepted the settlement offered by Southeastern Services, Inc. (SSI) to resolve the issues in the docket. As part of its settlement, SSI offered to contribute \$2,500 to the Florida General Revenue Fund and amend its certificates to include all pertinent information. The Commission ordered that the docket shall be closed administratively upon either receipt of the payment of the voluntary contribution or upon the cancellation of the company's certificates.

On August 2, 2005, Northeast Florida Telephone Company (NEFCOM) filed its protest of Order No. PSC-05-0734-PAA-TP. On October 20, 2005, the Commission issued Order No. PSC-05-1027-FOF-TP whereby it dismissed NEFCOM's Protest and deemed Order No. PSC-05-0734-PAA-TP final and effective. On October 27, 2005, SSI submitted to the Commission its voluntary contribution in the amount of \$2,500.

On November 16, 2005, NEFCOM filed its Notice of Administrative Appeal to the Florida Supreme Court of Commission Order No. PSC-05-1027-FOF-TP, issued on October 20, 2005. On November 15, 2006, the Florida Supreme Court issued its Order for voluntary dismissal of NEFCOM's appeal. Apparently, both parties reached an agreement to settle their differences. SSI amended its certificates as agreed and submitted its voluntary contribution in the amount of \$2,500, hence, this docket should now be closed administratively.
