The enclosed letter, dated October 12, 2006, was sent to your company regarding Verizon's, Embarq's, and BellSouth's intrastate switched access charges being reduced to interstate parity as a result of this Commission's Order No. PSC-03-1469-FOF-TL (Order) issued on December 24, 2003. The enclosed letter delineated the Interexchange Carrier (IXC) filing requirements as a result of the Order being issued. The filing requirements varied based on the access charges paid within the most current 12-month period by your company. Additionally, any IXC whose intrastate switched access expense reduction is \$100 or less per month would not be obligated to flow through its reduction, but must attest to such through a letter filed with this Commission. As of November 14, 2006, we are not in receipt of a response from your company. Please forward the required response no later than December 15, 2006.
