Dear Ms. Bayó:

This letter is in response to the letters from Beth W. Salek, on October 12, 2006 and November 16, 2006 in the above-referenced dockets. Please be advised that RNK Inc. d/b/a RNK Telecom Inc. (IXC Code: TJ725, "RNK") hereby informs the Commission that since its intrastate access expenses have been reduced by less than \$100.00 per month,¹ due to the access rate filings of Verizon-Florida and Embarq-Florida, it is not required to file tariff changes reflecting any flow-through of this reduction.

At this time, nearly all of RNK's Florida intrastate interexchange traffic is terminated by other carriers. Thus, any switched access expenses (or reductions thereto) would be built into the rates billed to RNK by its suppliers, and are not billed directly to RNK.
