Staff is requesting that we be permitted to make a modification to Item 7 on tomorrow's agenda. Item 7 is Docket No. 060488-EI, Complaint No. 665167E of Streamline Hotel. The change would appear on lines 1, 2 and 3 of the first full paragraph on page 6 of the recommendation. The purpose of the change is to clarify the conclusion and make it consistent with the recommendation. The change, in legislative format, would read as follows:

Conclusion

Based on the analysis above, staff recommends that the Commission find that the point of delivery for the Streamline Hotel began is at the weatherhead, owned by the property owner. The customer's responsibility begins at the weatherhead and continueds through wires connected to the current transformers from the weatherhead. The utility is responsible for the actual current transformers and any wiring connecting them to the meter. The customer's responsibility resumes where the wires exit the current transformers to connect to the load center. Staff recommends that the Commission find that FPL has not violated any tariff or commission rule as it relates to the complaint filed by customer Eric Doyle as owner of Streamline Hotel.
