Dear Mr. Rogow:

We are in receipt of your corrections and amendments to the application for transfer of majority organizational control. There are several remaining items that must be clarified.

First, confirmation has been provided that the new owners have little or no technical ability or experience in operating a utility. To assist the new owners in operating the utility, will experienced personnel be retained by the company? If, the experienced personnel staff is being retained, please provide a statement to that fact or a statement as to how technical ability will be achieved.

Secondly, to assist the new owners with an accurate accounting of the utility books and records, please submit a 2005 annual report that is reflective of the balances stated in Order No. PSC-96-1083-FOF-SU. For example, the utility collected CIAC, but there is no record of the CIAC collected in the annual report. Please resubmit the annual report with accurate balances of all accounts. CMP

Thirdly, as required by Rule 25-30.037(3)(i), F.A.C., please provide evidence that the utility owns the land upon which the utility treatment facilities are located, such as a deed or a copy of an agreement which provides for the continued use of the land, or 99-year lease. In addition, please provide a statement that the emergency phone number for the utility is listed or the lift stations. Staff can not proceed with the processing of this application, until the above mentioned items have been resolved.	ล า า
