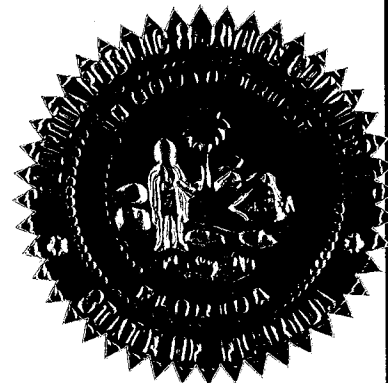

3 modification from our staff.

4 MS. FLEMING: Katherine Fleming for Commission Legal
5 staff.

6 Item 13 is to approve staff's recommendation to
7 approve the transfer of Ocala Springs to Marion County in the
8 State of Florida and to cancel the respective certificates.
9 The modification is on Issue 2, which is on Page 5 of the
10 recommendation.

11 This modification is to reflect that both Dockets
12 980876 and 060749 should be closed, so the issue statement
13 should read should these dockets be closed. The recommendation
14 in the staff analysis should read, "No. The dockets should
15 remain open and the certificates remain active pending
16 confirmation of the closing on the option agreement in Phase I
17 of the purchase agreement. Once confirmation of the closing
18 has been received, the certificates should be canceled
19 effective the date of the closing and the dockets should be
20 administratively closed," add a period and strike the remaining
21 part of the sentence.


