Dear Mr. Rendell:

When the Florida Department of Environmental Protection reissued River Ranch Water Management, LLC's operating permit it required River Ranch to slipline the first third of its collection system on or before December 31, 2006. The second third of the system is to be completed by the end of 2007, and the final third by the end of 2008.


