The problem (if that's what it is) relates to dates then. A pure adoption is presumptively valid upon receipt and the amendment has a 90 day statutory period. If we make this docket an "adoption, with modifications" or "adoption, with one amendment" then I think we'll have to go with a 90 day statutory deadline. I don't know if this is what BST intended, so I'm waiting on a call back.
