Dear Mrs. Bayó:

I am pleased to inform you that the merger between AT&T Inc. and BellSouth Corporation closed on December 29, 2006, at which time BellSouth Corporation became a wholly-owned, first-tier subsidiary of AT&T Inc.

As a result of the merger at the holding company level, BellSouth Telecommunications, Inc. ("BellSouth") will adopt the AT&T brand name for its products and services. The transition from the use of the BellSouth brand name to the AT&T brand name is expected to occur over the next few months.

To that end, BellSouth hereby respectfully requests that the Florida Public Service Commission ("Commission") approve an amendment to BellSouth's certificates (ILEC Certificate No. 8 and CLEC Certificate No. 4455) to include the d/b/a names "AT&T Florida" and "AT&T Southeast." While BellSouth will remain a corporate entity certificated in this State, with the Commission's approval, BellSouth will do business under the doing business as ("d/b/a") names of "AT&T Florida" or "AT&T Southeast." BellSouth is seeking approval for two d/b/a names so that one can be used for single state functions and/or products and services and one can be used to describe functions, activities and/or products and services that are uniform throughout the nine-state footprint. This request does not involve the transfer of any certificates.

BellSouth also is filing the required papers with the office of the Secretary of State to use the d/b/a names in this State. A copy of those papers is attached hereto as Exhibit A.

With regard to BellSouth's tariffs, BellSouth is filing concurrent with this letter new tariff cover pages reflecting the names under which BellSouth will be doing business in Florida.

The address of the post-merger operating company and the company contact information on file with the Commission remains unaffected by this d/b/a notice.
