

**Amendment to the Resale Agreement  
Between  
Minority Telecom Resalers, Inc. and  
BellSouth Telecommunications, Inc.  
Dated July 20, 2006**

This Amendment is entered into by and between Minority Telecom Resalers, Inc. (Minority Telecom) and BellSouth Telecommunications, Inc. ("BellSouth") hereinafter referred to collectively as the "Parties," to amend that certain Resale Agreement between the Parties dated July 20, 2006 ("Resale Agreement") to be effective as of the date of the last signature to the amendment.

WHEREAS, Minority Telecom has changed the name of said business to Minority Telecom Resalers, Inc. d/b/a North Dade Telecom (Minority Telecom), a Florida corporation;

WHEREAS, the Parties desire that the Resale Agreement be amended to reflect the correct corporate entity name; and


NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. The name of Minority Telecom Resalers, Inc. (Minority Telecom) in the Resale Agreement is hereby deleted throughout the Resale Agreement and replaced with Minority Telecom Resalers, Inc. d/b/a North Dade Telecom (Minority Telecom).
2. All of the other provisions of the Resale Agreement, dated July 20, 2006, shall remain in full force and effect.
3. Either or both of the Parties is authorized to submit this Amendment to each Public Service Commission for approval subject to Section 252(e) of the Telecommunications Act of 1996.
