



**PROGRESS ENERGY FLORIDA, INC.'S  
NOTICE OF WITHDRAWAL**

Progress Energy Florida, Inc. hereby withdraws its petition for approval of revised Rate Schedule RS-1 filed on August 25, 2006 in the above docket. Effective with the first billing cycle in April 2007, Progress Energy Florida will calculate prorated bills for its Rate Schedule RS-1 (Residential Service) in the following manner:

The Customer Charge will be calculated by dividing the actual number of days of the bill by 30 (normal billing month) and multiplying this fraction times the monthly customer charge. The Energy Charges (fuel and non-fuel) will be calculated by multiplying the tariff rates (RS-1 Tariff Sheet No. 6.120 and BA-1 Tariff Sheet No. 6.105) for the first 1000 KWH to the first 1000 KWH usage and the rates for greater than 1000 KWH to the usage above 1000 KWH regardless of the number of days of the bill. When a bill is required to be prorated due to the billing period being longer than a normal billing month, the billing will first be subdivided into the appropriate number of months (for both the Customer Charge and KWH usage) using 30 days as a normal billing month and only months with less than the normal billing month days will be prorated (in the manner described above).
