Dear Ms. Schneider:

The Commission received your letter today via fax asking how to "stop being required to file" the annual Regulatory Assessment Fee return since you stated the company has not operated any payphones in a few years.

All a company has to do is request cancellation of their certificate in writing, provide the reason why, and pay the current year's Regulatory Assessment Fee. Therefore, as soon as the 2006 Regulatory Assessment Fee return form and the minimum \$50 payment is received, I will open a docket to voluntarily cancel Centratel's pay telephone certificate and will use your faxed letter as the written request for cancellation.

Just as information, I pulled the company's 2005 Regulatory Assessment Fee return to see if there was a letter attached or a note on the form requesting cancellation, but there was not. The 2006 return form and minimum fee must be received by January 30th for the company not to be responsible for the 2007 fee.

Please confirm that you are requesting cancellation and if you are, please advise when we can expect the form and \$50 fee. Let me know if you have any questions.

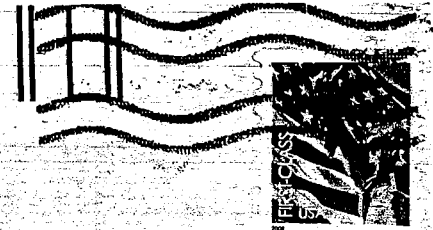
