This filing reduces per minute switched service usage rates. These rate reductions are being made in conjunction with Docket No. 030961-TI, Commission Order No. PSC-03-1461-FOF-TL and Florida Statute §364.163(2). The rate reductions represent the flow-through obligations of Business Telecom, Inc. in response to this order.

Business Telecom, Inc. is also submitting work papers in support of this filing to Ms. Blanco Bayo. Portions of the materials supplied are confidential and are being filed according to Chapter 364.183(1), Florida Statutes. A copy of the redacted work paper is attached to this filing for coordination purposes.

In addition, an inadvertent error was found on page 112 of this tariff. Effective November 1, 2005, Switched Long Distance Service (199) First Choice's per minute rate was reduced by 2.25% to \$0.0660 in conjunction with Docket No. 030961-TI, Commission Order No. PSC-03-1461-FOF-TL and Florida Statute §364.163(2). However, due to a typographical error, the \$0.0660 rate was entered in the tariff as \$0.0600. Due to this error, the current reduction on page 112 appears to be an increase. However, the new rate of \$0.630 is actually a 4.47% reduction.

4.67 BTI Switched Long Distance

BTI Switched Long Distance is a direct dialed outbound and inbound long distance service designed for Business Customers who subscribe to BTI's facilities based local exchange service. The Customer must have three or more lines and sign a one-year term agreement for this service. Calls are billed in six (6) second increments following an initial billing period of eighteen (18) seconds. Intrastate service is offered in conjunction with interstate service.

5.5 Corporate Connections *

Corporate Connections is a combined outbound and inbound service designed for business Customers that subscribe to BTI service within the eligibility period specified below. Calls are billed in six (6) second increments after an initial period, for billing purposes, of thirty (30) seconds. There is an interstate monthly recurring charge associated with this product. Customers must sign a one year or three year term plan for this product. Three year term plan customers also must commit to \$500 in monthly volume to be eligible for the reduced rate.
