As you are aware, Order No. PSC-05-1242-PAA-WS, issued December 20, 2005, in Docket Nos. 040951-WS and 040952-WS, approved the transfer of Florida Water Services Corporation's systems in Brevard, Highlands, Lake, Orange, Pasco, Polk, Putnam, Seminole, Volusia and Washington Counties to Aqua Utilities Florida, Inc. (AUFU). In the above-referenced docket, Aqua America, Inc. (AUFU's parent corporation), requested that the names of its remaining systems Alachua, Highlands, Lake, Lee, Marion, Palm Beach, Pasco, Polk and Sumter Counties be changed to AUFU. As part of the filing in the docket, all of AUFU's certificates were returned for possible amendment.

Order No. PSC-06-0973-FOF-WS, issued November 22, 2006, which approved the name change, also noted that AUFU's Certificate Nos. 2-W (Brevard County), 359-S (Highlands County), 84-W (Orange County), 284-S and 76-W (Putnam County), 226-S and 279-W (Seminole County), 182-S and 238-W (Volusia County) and 435-S and 501-W (Washington County), remained unchanged by the actions of the order and are hereby being returned. Please ensure that they are forwarded to AUFU to be maintained on file in the utility office(s). The certificates that were affected by the actions of Order No. PSC-06-0973-EOF-WS, were reissued as attachments to that order.
