In a document request, a company spokesperson stated that an adjustment had not been made to correct the customer billing error for the cycle ending April 8, 2005. The spokesperson further explained that the utility will take appropriate action and correct the billing to the prorated rates and credit the applicable customers affected. Please provide the transactions and the documents supporting the billing corrections and the customer credits.
