

NOTICE is hereby given on this 15th day of February, 2007, pursuant to Rule 25-22.0407, Florida Administrative Code, that Key Haven Utility Corporation has filed a Petition for a wastewater rate increase with the Florida Public Service Commission. The general reason for the requested increase is to allow the Utility to be given an opportunity to recover the cost of its continuing project for slip lining and main replacement in order to reduce saltwater infiltration of the collection system which has been identified by the Florida Department of Environmental Protection as the cause for the wastewater treatment plant operating in an upset condition.

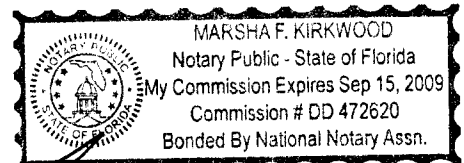
