

2 CHAIRMAN EDGAR: We have one more item that we need
3 to address on our agenda today, which is --

4 COMMISSIONER CARTER: 27.

5 CHAIRMAN EDGAR: Thank you, Commissioner Carter. We
6 are on Issue 27. Is our staff ready?

7 Mr. Fletcher.

8 MR. FLETCHER: Commissioners, Bart Fletcher with
9 staff.

10 Item 27 is staff's recommendation on final rates for
11 Sanlando Utilities Corporation. Sanlando is a Class A water
12 and wastewater utility in Seminole County. It's my
13 understanding that the representatives for OPC and the utility
14 are here to address any questions the Commissioners may have,
15 and staff is available to answer any questions that the
16 Commission may have.

17 CHAIRMAN EDGAR: Thank you, Mr. Fletcher. Mr.
18 Reilly, do you have concerns about any of the issues included
19 in Item 27?

20 MR. REILLY: Madam Chairman, I have some very good
21 news for you today.

22 MR. FRIEDMAN: We could sing in harmony.

23 MR. REILLY: It's not that we don't have issues, but
24 that we do not choose to share them, you know, bring them to --
25 that rise to the level of this discussion. So, unless you have

1 questions of us, I think we can move forward.

2 CHAIRMAN EDGAR: Okay. So, Mr. Reilly, not to speak
3 for you, but it is my understanding that the Office of Public
4 Counsel is comfortable with the staff recommendation as
5 presented before us?

6 MR. REILLY: That's not what I said. I said that I
7 was not going to bring issues to your attention at this agenda
8 conference.

9 CHAIRMAN EDGAR: All right. We'll take it from
10 there, then. Thank you.

11 And, Mr. Friedman.

12 MR. FRIEDMAN: We are just here to answer questions.

13 CHAIRMAN EDGAR: Okay. Thank you very much.

14 Commissioners, any questions on any of the issues
15 identified as part of Number 27?

16 COMMISSIONER CARTER: Move staff.

17 CHAIRMAN EDGAR: Commissioner McMurrin.

18 COMMISSIONER McMURRIAN: He was afraid I was going to
19 have questions. No, I don't. Second.

20 CHAIRMAN EDGAR: I am never fearful of questions.
21 Okay.


