Thank you for the prompt response. To ensure we properly credit your payment of \$50, please just add on your check the following:

Again, I apologize if we have failed to return your phone calls regarding how to cancel a certificate. We will cancel your certificate effective December 31, 2006. By making the payment, you will be leaving in good standing with the Commission, which eliminates any barriers should you decide to re-enter the market in the future. As we discussed, the minimum payment of \$50 applies no matter when in 2006 the cancellation would have taken affect.

A docket has already been established to handle the cancellation. It is docket 070105-TC. You will most likely receive an administrative order in the mail announcing the cancellation. There is nothing more you will need to do at this point.
