**AT&T FLORIDA'S
REQUEST FOR SPECIFIED CONFIDENTIAL CLASSIFICATION**

COMES NOW, BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T Florida"), pursuant to Rule 25-22.006, Florida Administrative Code, and Section 364.183, Florida Statutes, and files its Request for Specified Confidential Classification.

1. On February 23, 2007, AT&T Florida filed its Petition for Relief from Carrier-of-Last-Resort Obligations Pursuant to Florida Statutes §364.025(6)(d) ("Petition") regarding the Villages of Avalon, Phase II development ("Avalon"). Attached to the Petition were a number of exhibits. Avalon's Developer claims that Exhibit "B" contains information that is "confidential" and "privileged." AT&T Florida does not believe that Exhibit "B" contains "confidential" or "privileged" information; however, in the spirit of cooperation, AT&T Florida has agreed to seek a claim of confidentiality with regard to Exhibit "B." Therefore, AT&T Florida requests that the documents contained in Exhibit "B" be replaced with the attached, redacted versions and that Exhibit "B" be deemed "confidential."

2. Pursuant to Rule 25-22.06(3)(a), AT&T Florida hereby files this Request for Specified Confidential Classification because the information contained in AT&T Florida's Petition is alleged to be "confidential" by the Developer. A more specific

description of this information is contained in Attachment A. Therefore, such information should be classified as confidential information pursuant to Section 364.24 and Section 364.183, *Florida Statutes*. Accordingly, it should be held exempt from the public disclosure requirements of Section 119.07, Florida Statutes.

3. Attachment A to AT&T Florida's Request for Confidential Classification contains an explanation of the confidential information along with a list that identifies the location of the information designated as confidential.

4. Attachment B to AT&T Florida's Request for Confidential Classification is redacted copies of the document containing the confidential information.

5. Attachment C to AT&T Florida's Request for Confidential Classification is a highlighted copy of the document containing the confidential information.

6. The original of this Request was filed today with the Division of the Commission Clerk and Administrative Services and a copy was served on the Parties.


