Dear Ms. Bayó:

We are the attorneys for Acceris Management and Acquisition, LLC ("Acceris"). On December 7, 2006, Acceris, New Access Communications LLC, and First Communications LLC ("First Communications") submitted a joint petition for a waiver of carrier selection requirements of Rule 25-4.118, Florida Administrative Code and included a request to cancel the CLEC Certificate No. 8371 and IXC Registration No. TK011 ("the Certifications") held by Acceris, effective March 1, 2007.

On behalf of Acceris, we respectfully request an Amended Order reinstating the Certifications held by Acceris and moving the effective date of cancellation to June 30, 2007. In support of this request, we provide the following:

1. On March 16, 2007, BellSouth notified Acceris that they would immediately terminate the Commercial Agreement pursuant to Section 2.1, which states:

*Prior to execution of this Agreement, CUSTOMER agrees to provide BellSouth in writing CUSTOMER's CLEC certification for all states covered by this Agreement except Kentucky. Should CUSTOMER's certification in any state be rescinded or otherwise terminated, BellSouth may, at its election, terminate this Agreement immediately and all monies owed on all outstanding invoices shall become due, or BellSouth may refuse to provide Services hereunder in that state until certification is reinstated in that state. CUSTOMER shall provide proof of authority to do business, issued by the Secretary of State, or equivalent authority, in each state covered by this Agreement.*

2. Applicants underestimated the time needed to seamlessly transition the customer accounts from Acceris to First Communication. The parties require the Certifications held by Acceris to remain active until June 30, 2007 to allow First Communications time to complete the transition of the customer base, and to either assume the interconnection agreement with BellSouth or negotiate a new agreement.
3. The loss of telephone service as a result of the premature cancellation of the Certifications and subsequent termination of the interconnection agreement will negatively impact the customers currently being served under the Certifications and terms of the Agreement.
4. Acceris will voluntarily relinquish the Certifications, effective June 30, 2007, and pay any additional 2007 Annual Regulatory Assessment Fees as required by the Commission.
