





CUSTOMER NOTICE

ISSUED: April 6, 2007

On August 22, 2006, Mid-County Services, Inc. (*Utility*), completed its application to the Florida Public Service Commission (*Commission*) for increased wastewater service rates, in which it requested an interim wastewater rate increase of 12.81%, and a final wastewater rate increase of 27.13%. The Commission approved an interim wastewater rate increase of 10.21% subject to refund with interest by Order No. PSC-06-0653-PCO-SU, dated August 7, 2006.

At the Agenda Conference held on January 23, 2007, the Florida Public Service Commission took action on the Utility's application. By Proposed Agency Action (PAA) Order No. PSC-07-0134-PAA-SU, issued February 16, 2007, the Commission approved a wastewater rate increase of 20.29%. In addition, the Commission approved revised miscellaneous service charges. These rates and charges are designed to allow the Utility the opportunity to recover its reasonable and prudent costs for providing service, and a reasonable rate of return on its investment in facilities necessary to provide such wastewater service.

The increased rates and charges approved by the Commission are effective for service on or after April 7, 2007.

The rates and charges prior to filing, the Commission-approved interim rates, and the newly approved rates for wastewater service and miscellaneous service charges are attached to this customer notice.
