



CUSTOMER NOTICE

ISSUED: April 2, 2007

On August 22, 2006, Labrador Utilities, Inc. (*Utility*), completed its application to the Florida Public Service Commission (*Commission*) for increased water and wastewater service rates, in which it requested interim water and wastewater rate increases of 36.95% and 28.55%, respectively, and final water and wastewater rate increases of 68.436% and 42.45%, respectively. By Order No. PSC-06-0668-FOF-WS, dated August 7, 2006, the Commission approved an interim water rate increase of 30.06% and an interim wastewater rate increase of 14.91%, subject to refund with interest.

At the Agenda Conference held on January 23, 2007, the Commission took action on the Utility's application. By Proposed Agency Action Order No. PSC-07-0129-SC-WS ("PAA Order"), issued February 14, 2007, the Commission denied a final increase in water and wastewater rates and ordered the Utility to refund the interim revenue increase, with interest, collected during the pendency of the rate case. The refund will appear on customers' April, 2007 bills. The rates prior to filing will be in effect commencing March 7, 2007.

The rates prior to filing and the Commission-approved interim rates for water and wastewater service are set out below.
