On December 11, 2006, this Commission received a petition from the company's attorney, Edward S. Quill, Jr. of Williams Mullen, advising of a corporate transfer and consolidation of TelCove of Jacksonville, Inc., holder of IXC Registration No. TJ346 and TelCove Investment, LLC, holder of IXC Registration No. TJ206, requesting cancellation of IXC tariffs and removal from the IXC Registration List upon completion of the transfer and consolidation of TelCove companies. The 2007 Regulatory Assessment Fee will be paid no later than 30 days from the date of the Final Memo providing the specific effective date of the cancellations, as required by Section 364.336, Florida Statutes. If TelCove of Jacksonville, Inc. or TelCove Investment, LLC commence operations in Florida as an intrastate interexchange carrier in the future, new registrations must be filed.

The Commission also received contact information and a tariff from TelCove Operations, Inc. Staff has determined that the documents received meet the requirements of Section 364.02(13), Florida Statutes. TelCove Operations, Inc. is assigned TK121 as its IXC Registration Code for the state of Florida and will be adopting TelCove Investment, LLC's tariff currently on file with the Commission. As required by Section 2.07.C.5.h., Administrative Procedures Manual, the company has provided the required contact information to be acknowledged as a registered intrastate interexchange telecommunications company.
