ORDER GRANTING RENEWED MOTION TO HOLD DISCOVERY IN ABEYANCE

On July 27, 2006, AT&T filed its Renewed Motion to Hold Discovery in Abeyance (Motion). In its Motion, AT&T states that on June 30, 2006, Embarq served its First Set of Interrogatories and First Request for Production of Documents on AT&T. AT&T states further that on July 10, 2006, it filed its Motion to Dismiss the Complaint or Alternatively Hold the Proceeding in Abeyance (Motion to Dismiss).

On July 28, 2006, Embarq filed its Response to AT&T's Motion. Embarq requests the Commission deny the relief sought by AT&T and further asserts that "Embarq has been trying to obtain this information from AT&T for a considerable amount of time to enable the parties to resolve this issue." Alternatively, Embarq states that if the Commission grants AT&T's request to suspend discovery, a date should be set for AT&T to provide its responses to Embarq's discovery in the event the Commission denies AT&T's Motion to Dismiss. Embarq argues further that it will be prejudiced if it is unable to obtain the information it has requested prior to the filing of testimony in this proceeding. Consequently, Embarq contends that two weeks from the Agenda Conference ruling on the Motion to Dismiss would be a reasonable due date for responses and would not unnecessarily delay the filing of testimony should the Commission deny the Motion to Dismiss.

Upon consideration, it appears reasonable and appropriate to grant AT&T's Motion with the caveat that in the event the Commission denies AT&T's Motion to Dismiss or Alternatively Hold the Proceeding in Abeyance, AT&T shall serve its responses to Embarq's First Set of Interrogatories and First Request for Production of Documents no later than fourteen calendar
