**Re: Docket No. 060122-WU - In re: Joint petition for approval of stipulation on procedure by Aloha Utilities, Inc. and Office of Public Counsel.**

Dear Mr. Deterding:

By this letter, the Commission staff is amending our first data request dated April 17, 2007. Staff needs the following information to complete our review of the installation of chloramination facilities by Aloha Utilities, Inc. (Aloha or utility).

By Order No. PSC-06-0169-S-WU, issued March 1, 2006, the Commission approved a stipulation on procedure between Aloha and the Office of Public Counsel (OPC), in which the Commission will process a limited proceeding application by the utility and will not expand the scope of the proceeding beyond issues related to the chloramination facilities and the additional water purchased (including the cost of any interconnection facilities, any required impact fees, and any related reduction in Aloha's water treatment costs). Moreover, by Order No. PSC-06-0270-AS-WU, issued April 5, 2006, the Commission approved a settlement agreement between Aloha and the OPC which stated that the recovery of the portion of the cost that related solely to the use of hydrogen peroxide may be litigated in Phase III of the limited proceeding for the anion exchange treatment facilities. In effort to comply with the above requirements and to address customer concerns, please provide the following requested information.

1. When were the chloramination facilities placed into service?
2. With regard to all the invoices that Aloha provided to the Commission auditors which related to the chloramination facilities, please provide a schedule identifying any invoice which also related to the hydrogen peroxide treatment option. For each invoice that relates to both the chloramination facilities and the hydrogen peroxide treatment option, provide a breakdown for the total amount for the hydrogen peroxide treatment option and explain why any amount on the invoice does not relate to the hydrogen peroxide treatment option.


