Dear Mr. Bahret:

There are two kinds of cancellation. One is voluntary, which is when a certificate holder pays any past due and current Regulatory Assessment Fees, and leaves in good standing. The second type of cancellation is involuntary and is when a certificate is cancelled on the Commission's own motion for violation of a rule, order, or statute. The Regulatory Assessment Fee is applicable if a certificate is active for any day during a calendar year.

In this case, you owe a \$6 penalty and interest charge for late payment of the 2006 fee (payment was due by January 30th; payment was postmarked March 15th, and the 2007 minimum fee of \$100 for a total due of \$106.

I am attaching a breakdown of the late payment charge and the 2007 Regulatory Assessment Fee return form which should be completed and returned with full payment. Please respond by May 9, 2007. Let me know if you have any questions.
