Request for Permission from Department of Financial Services to Write-Off the Uncollectible RAFs

On December 20, 2006, Docket No. 060815-TI was established to address the cancellation of Corporate Services Telcom, Inc.'s intrastate interexchange telecommunications (IXC) Registration No. TI446 due to bankruptcy.

By Order No. PSC-07-0136-PAA-TI, the Commission granted cancellation of Corporate Services Telcom, Inc.'s IXC Registration No. TI446, effective December 31, 2006. The Commission further ordered that the Division of Administrative Services shall be notified that the unpaid Regulatory Assessment Fees (RAFs) shall not be sent to the Department of Financial Services for collection, instead permission for the Commission to write-off the uncollectible amounts will be requested.

Therefore, staff requests that the Fiscal Services Section take the appropriate steps to seek permission from the Department of Financial Services to write-off the uncollectible amount.
