


1. Pursuant to the Order Granting Proposed Joint Procedural Schedule, Order No. PSC-06-0326-PCO-TL, issued April 21, 2006, and the Parties Joint Second Motion for Extension of Filing Dates filed March 15, 2007, direct briefs are currently to be filed by the Parties on or before May 25, 2007, and reply briefs on or before June 11, 2007. The Parties hereby request an additional extension of forty-five (45) days, which would make direct briefs due on July 9, 2007, and reply briefs due on July 24, 2007.
2. Said extension will allow AT&T Florida and the County to continue to discuss settlement alternatives. In addition, the extension will permit the Parties additional time to compile a complete set of the voluminous exhibits for use by the Parties in preparing their briefs and by the Commission in its review.




