On May 11, 2007, dPi Teleconnect, L.L.C. ("dPi") and BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T Florida") filed a Joint Motion for Continuance requesting that the Commission continue the hearing and suspend all prehearing deadlines established in Order No. 07-0332-PCO-TP until 10 days after the Administrative Law Judge in Louisiana Public Service Commission Docket No. U-29172 issued an order resolving the pending discovery disputes in that proceeding. On May 25, 2007, the Louisiana Administrative Law Judge issued her ruling. Accordingly, based upon the parties' Motion, dPi and AT&T Florida respectfully request that the Commission reestablish prehearing deadlines, including testimony and discovery timeframes, and a new hearing date in the above-captioned docket.
