Kira, we issued the order approving settlement in this docket earlier today. It was brought to my attention after issuance that the order should have been titled as a PAA; it should also have had the PAA notice language (last page of the order) with a space for protest due date rather than final action language-- though the ordering paragraphs do reflect it's PAA.

Perhaps the best way to correct this is to "reissue" order PSC-06-0320-AS-TI, where you have an explanatory paragraph at the beginning of the order to explain the purpose and the corrections, then say it's a reissuance of Order PSC-06-0320-AS-TI. That will also allow us to use the "PAA" designation in the new order number.

Please let me know if this isn't clear.
