**REQUEST FOR DEFERRAL OF AGENDA CONFERENCE**

This matter is scheduled for an agenda conference for January 19, 2007, 9:30 am, before the Public Service Commission. Litestream Holdings, LLC ("Litestream") respectfully requests a deferral of the agenda conference. The Commission staff issued the notice of the agenda conference on June 8, 2007. Litestream's counsel did not receive notice of the agenda conference until June 15, 2007, and is unable to attend the agenda conference on June 19, 2007. In addition, because of traveling, counsel for Litestream has not had an opportunity to consult with his client to discuss this matter.

Litestream would request a short deferral, to the Commission's next agenda conference scheduled for July 10, 2007, to determine if this matter can be resolved pursuant to an agreed-upon stipulation with BellSouth Telecommunications, Inc. d/b/a AT&T Florida. This would be an efficient use of the parties' and the Commission's resources, and thus, in the public interest, as opposed to proceeding with a dismissal without prejudice of Litestream's Complaint. Litestream's counsel represents that he contacted counsel for AT&T Florida, but is not authorized to represent that AT&T Florida consented to this request. A short deferral of the agenda conference will not prejudice the parties.




