

## PRELIMINARY SEPTEMBER 2007 DATA NOTIFICATION

BellSouth Telecommunications, Inc., d/b/a AT&T Georgia ("AT&T Georgia") is considering making the changes described in this document to generate results for the September 2007 data month. Results for the September 2007 data month will be posted as follows:

Preliminary results	October 22, 2007
Final results	October 31, 2007

AT&T Georgia provides Data Notifications each month in compliance with the SQM Plan. This order specifies that when AT&T Georgia proposes making any changes to the methods by which performance data is calculated, it must provide written notice. This notice must be provided on the first business day of the month before the data month in which the change will be made. AT&T Georgia must also provide notification if it is considering making changes to the method of calculating data for the following month.

ENCORE Releases may affect monthly data flows from the source systems (e.g., LEO, LESOG, etc.) that PMAP uses to calculate measurements. AT&T Georgia will make changes to PMAP to ensure that data continues to be correctly captured as ENCORE Releases are implemented.

System releases related to the merger between BellSouth and AT&T may affect monthly data flows from the source systems that PMAP uses to calculate measurements. AT&T Georgia will make changes to PMAP to ensure that data continues to be correctly captured as system changes are implemented.

### Ordering Measurements

- (1) *Affected Measures:* O-8 (RI)

*Description of Change:* Currently, PMAP is multiplying the denominator by 4 on the Aggregate report for the product Local Interconnection Trunks. AT&T Georgia proposes to modify PMAP so that the denominator and metric on the Aggregate reports matches the correct denominator and metric as shown on the 12-month reports. (RQ8871)

*Impact of Change:* The denominator and metric on the Aggregate reports will match the denominator and metric on the 12-month reports for the product Local Interconnection Trunks.

### Provisioning Measurements

- (2) *Affected Measures:* P-13C (LAT)

*Description of Change:* Currently, PMAP is capturing Remote Call Forwarding records in its data. AT&T Georgia proposes to exclude the Remote Call Forwarding records to

comply with the exclusions for this measure as identified in the Regional SQM. (RQ9093)

*Impact of Change:* For April 2007 data in Florida, the LNP metric would change from 99.93% to 99.94%.

For April 2007 data in Georgia, the LNP metric would not change.

### **Special Access Measurements**

(3) *Affected Measures:* SA-9

*Description of Change:* Currently the annualized calculation for Failure Rate includes more than 12 months of data. AT&T Georgia proposes to change calculation to a 12-month annualized rate as per the SQM. (RQ9172)

*Impact of Change:* For April 2007 data in Florida, the IXC DS0 Annualized Failure Rate would change from 3.96% to 3.38 %. The Retail DS0 Annualized Failure Rate would change from 5.59 % to 4.51 %.

For April 2007 data in Georgia, the IXC DS0 Annualized Failure Rate would change from 3.69% to 3.20 %. The Retail DS0 Annualized Failure Rate would change from 4.24 % to 3.11 %.
