Thank you for your letters dated September 23 and 27, 2007, to the Commission Chairman's Office. The Chairman's Office has asked me to respond to your letters.

Please be advised that we are closely monitoring the progress of Aloha Utilities, Inc. (Aloha or utility) towards the implementation of the settlement agreement and construction of the anion exchange treatment facilities. We will continue to meet with Aloha and the parties to the settlement agreement on at least a quarterly basis until the project is completed. If the Commission staff concludes at any point along the way that Aloha is not proceeding in good faith to meet the schedule for implementation of the treatment facilities and that enforcement is warranted, we will recommend that the Commission take enforcement action.
