Good Afternoon,

In response to your inquiry, please note the docket number you gave me was for a rulemaking proceeding (national electric code updates). The correct docket number is 070346-TA.

I have attached Rule 25-4.0161 which describes the payment of regulatory assessment fees and the penalties for not complying with the rule. I have highlighted the pertinent parts. To avoid any future penalties, please ensure you submit the completed regulatory assessment fee form and submit payment to the Commission no later than January 30 of each year. If this is a problem, you will see in the rule instructions for obtaining an extension. You are mailed the form in the middle of December each year. This is the second time A.Surnet has been docketed and each time it costs you more than before. First time it was \$500, now this second time it is \$1,000. You can see all this in the rule. The first docket was 060463-TA, which occurred just last year.

The reason A.Surnet is charged the second time is based upon the rule. Since the company did not pay the fee by January 30, a delinquent notice was mailed via certified post. Your shop signed for the notice on February 26. Thus, to avoid the penalty you are now faced with, the company should have submitted the regulatory payment with a postmark no later than March 13 (e.g., 15 days from the date it was received by your company). The payment and form you submitted was postmarked March 15. Yes, it was only 2 days late. However, we are not given any flexibility on this. One day or 40 days, the penalty applies the same.

I have attached the certified mail receipt showing the delinquent letter was received by A.Surnet on February 26, and the envelope you mailed the payment in, which was postmarked March 15.

To resolve this matter:

1. Submit payment of \$1,000 no later than **JULY 20, 2007**.
2. Identify that it is for settling Docket 070346-TA and identify the company name.

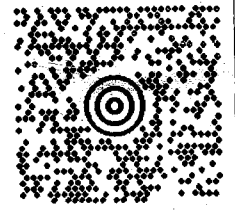

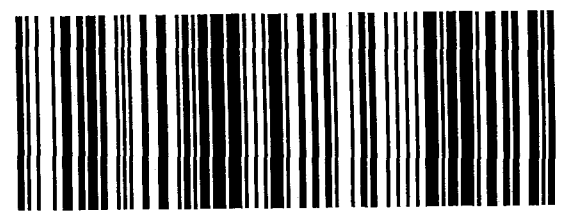
