BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T Florida") pursuant to Rule 25-22.006, Florida Administrative Code, hereby files its Motion for Extension of Duration of Order Nos. PSC-06-0042-CFO-TP and PSC-06-0043-CFO-TP Granting Confidential Classification, and states as grounds in support thereof the following:

1. On January 17, 2006, the Florida Public Service Commission (the "Commission") issued two Orders granting AT&T Florida's Request for Confidential Treatment of Document Nos. 09875-05 and 09280-05.
2. The reasons AT&T Florida asserted in support of confidential treatment in its original Requests for Confidential Treatment remain. Specifically, there remains a need to protect proprietary business information and competitive interests which is not subject to public disclosure.
3. The information requested remains in the possession of the Commission Staff.
4. For the reasons set forth above, and in AT&T Florida's original Requests for Confidential Classification, AT&T Florida hereby requests that the Commission enter

an order extending the period of confidential classification for an additional 18 months,  
or for any longer period of time that the documents remain within the possession of Staff.


