Dear Mr. Lane:

The Florida Public Service Commission received your letter dated July 3, 2007, addressed to the Florida Department of State, Division of Corporations. The Florida Public Service Commission and the Florida Department of State are two separate state agencies.

To help clarify, you engaged the Nowalsky, Bronston, & Gothard law firm in 2002 to file an application with the Florida Public Service Commission seeking authorization to sell telecommunications services in Florida. This action was separate and distinct from any action you may have taken with the Florida Department of State, Division of Corporations.

In my March 14th note to you I stated "Although the company may have dissolved in 2005 and sold its assets in January 2006, the Florida Public Service Commission was not notified that the company was no longer in business until March 2007.


Because the Florida Public Service Commission was not notified, Order No. PSC-07-0503-PAA-TI was issued on June 12, 2007, denying Line 1 Communications, LLC a voluntary cancellation of its IXC registration. The company had until July 3, 2007, to protest the Order. Your letter was not received until July 9, 2007, therefore, it cannot be considered a protest. In addition, Consummating Order PSC-07-0574-CO-TI was issued July 10, 2007, which finalized the first order and closed the docket.

In reviewing the documentation provided in your July 3, 2007, letter, it appears that Mr. Lammert handled the withdrawal of your corporate registration with the Florida Department of State, Division of Corporations. You may want to consult with him regarding the cancellation of your IXC registration with the Florida Public Service Commission.

NOTICE OF PROPOSED AGENCY ACTION ORDER
CANCELING INTRASTATE INTEREXCHANGE TELECOMMUNICATIONS TARIFF AND
REGISTRATION ON THE COMMISSION'S OWN MOTION

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Line 1 Communications, LLC d/b/a Direct Line Communications currently holds Intrastate Interexchange Telecommunications (IXC) Registration No. TJ656, issued by this Commission on May 20, 2002. Pursuant to Section 364.336, Florida Statutes, telecommunications companies must pay a minimum annual Regulatory Assessment Fee for each certificate or registration if the certificate or registration was active during any portion of the calendar year. Pursuant to Rule 25-4.0161(2), Florida Administrative Code, the form and applicable fees are due to the Florida Public Service Commission by January 30 of the subsequent year. Pursuant to Section 350.113(4), Florida Statutes, the Regulatory Assessment Fee return forms, for the period of January 1 through December 31, are mailed to entities at least 45 days prior to the date that payment of the fee is due. In addition, Rule 25-24.474, Florida Administrative Code, provides that intrastate interexchange companies must pay any current and past due Regulatory Assessment Fees with its request for cancellation.

On March 1, 2007, the Commission received a letter from the company's manager, Gene "Skip" Lane, Jr., dated February 26, 2007, requesting cancellation of Line 1 Communications, LLC d/b/a Direct Line Communications' IXC registration. On March 14, 2007, our staff faxed

ORDERED that the cancellation of the IXC tariff, including removal of its name from the register, in no way diminishes Line 1 Communications, LLC d/b/a Direct Line Communications' obligation to pay the applicable Regulatory Assessment Fees. If Line 1 Communications, LLC d/b/a Direct Line Communications' IXC tariff is cancelled and its name removed from the register, and the company subsequently decides to reregister as an intrastate interexchange telecommunications company, that company shall be required to first pay any unpaid Regulatory Assessment Fees, including accrued statutory late payment charges. It is further

ORDERED that if Line 1 Communications, LLC d/b/a Direct Line Communications pays the Regulatory Assessment Fees prior to the expiration of the Proposed Agency Action Order, the cancellation of the tariff and removal of its name from the register shall be deemed voluntary. It is further

ORDERED that if Line 1 Communications, LLC d/b/a Direct Line Communications does not pay the Regulatory Assessment Fees prior to the expiration of the Proposed Agency Action Order, the collection of the Regulatory Assessment Fees shall be referred to the Florida Department of Financial Services for further collection efforts. It is further

ORDERED that if Line 1 Communications, LLC d/b/a Direct Line Communications' IXC tariff is cancelled and its name removed from the register in accordance with this Order, the company shall immediately cease and desist providing intrastate interexchange telecommunications service in Florida. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Office of Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings" attached hereto. It is further

ORDERED that in the event this Order becomes final, this docket shall be closed upon receipt of the Regulatory Assessment Fees, or upon cancellation of the IXC tariff and removal of the company's name from the register.

Dear Mr. Lane:

The Commission received your letter dated March 8, 2007, requesting cancellation of the company's IXC registration because it is no longer in business. First, there are two types of cancellation. One is voluntary, which is when a registration is cancelled and the company leaves in good standing. The other is involuntary, which is when a registration is cancelled on the Commission's own motion for a rule, statute, or order violation.

Although the company may have dissolved in 2005 and sold its assets in January 2006, this Commission was not notified that the company was no longer in business until March 2007. Since there is a minimum annual Regulatory Assessment Fee, this means that Line 1 Communications, LLC d/b/a Direct Line Communications owes the 2006 fee plus \$6 late payment charges, for a total due of \$56.

The company has two options at this point. One is to leave in good standing by paying the 2006 Regulatory Assessment Fee plus late payment charges for 2006. The other is to not pay the outstanding fee. In that case, staff would recommend that the Commission deny your request for cancellation and instead cancel the registration on the Commission's own motion. Any unpaid fees would be turned over to collections.

I am attaching the 2006 Regulatory Assessment Fee return form in case you decide to pay the fee. Please review this information and let me know by March 29, 2007, how you wish to proceed. Please let me know if you have any questions or wish to discuss this.



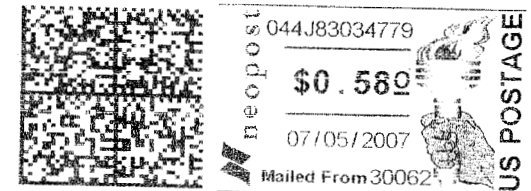
