Dear Mr. Pelzer:

I wanted to follow up and touch base with you. As far as your CLEC certificate is concerned, Pelzer Communications Corporation just owes the \$500 fine for not paying the Regulatory Assessment Fee (RAF) within

15 days of receipt of the delinquent notice. Our records show the delinquent notice was delivered on February 26, 2007, and the last day to pay to avoid the automatic fine was March 13, 2007. The 2006 RAF was postmarked March 19, 2007. The \$500 fine must be received by July 20,
