AT&T FLORIDA'S REQUEST FOR SPECIFIED CONFIDENTIAL CLASSIFICATION

COMES NOW, BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T Florida"), pursuant to Rule 25-22.006, Florida Administrative Code, and Section 364.183, Florida Statutes, and files its Request for Specified Confidential Classification.

- 1. On July 25, 2007, AT&T Florida filed its LSR Clarification Issues Matrix, which contains information that is confidential and proprietary.
- 2. Pursuant to Rule 25-22.06(3)(a), AT&T Florida hereby files this Request for Specified Confidential Classification because the information contained in AT&T Florida's LSR Clarification Issues Matrix contains confidential business information related to ordering methods used by AT&T Florida to conduct business with Competitive Local Exchange Carriers ("CLECs"). A more specific description of this information is contained in Attachment A. In addition, public disclosure of this information would cause harm to AT&T Florida and certain CLECs. Therefore, such information should be classified as confidential business information pursuant to Section 364.24 and Section 364.183, *Florida Statutes*. Accordingly, it should be held exempt from the public disclosure requirements of Section 119.07, Florida Statutes.

Explanation of Proprietary Information
