TK058 appears on the list of IXCs for RAF violations. In doing research, I printed a letter dated 03/08/07 from RAF System. The letter enclosed payment of the 2006 RAFs for both the LLC and the Inc. The letter goes on to state that its consultant (Regnum Group) filed its application for the LLC on 02/13/06 and failed to request cancellation on the Inc. at the same time. The application letter from Regnum does not make reference to the Inc.

I need to open a docket to cancel the Inc. but don't know whether to give them a 2006 or 2007 effective date. The Inc. is paid up thru 2006. Please advise what the effective date should be.
