Dear Mr. Clark,

Based on several conversations with your office staff, Linda, it appears that Mr. Uddo only sold the St. Johns Landing development and not the utility. According to your staff, when Mr. Uddo filed the transfer application listing him as both the seller of the utility and the buyer, he was attempting to transfer the utility certificates into his own name. The transfer application was filed as a result of St. Johns Landing of Putnam County Utilities Services, Inc. administrative dissolution.

Mr. Uddo needs to either complete his transfer application or an application to cancel the certificates. In order for the transfer application to proceed or the cancellation of the certificates to take place, the noticing requirements must be completed. Please refer to Commission Rule 25-30.030, Florida Administrative Code, for the noticing requirements. Noticing must be done in the proper format, consistent with the rule. If the notice is not in the proper format, you will be required to renotice and the application will be delayed. A list of the water and wastewater utilities and governmental/regulatory agencies that must be noticed was mailed to your office last month. Also, your staff was made aware of the expiration date of the noticing list. If you intend to request cancellation of the utility's certificates, refer to Commission Rule 25-30.036(4), Florida Administrative Code.

Please inform us on how you wish to proceed with this application and complete the appropriate filing requirements by **August 15, 2007**. Please be sure to refer to the docket number and direct the response to:


