Copies of the confidential documents are attached hereto as exhibit "A".


3. Gulf Power Company's responses to requests numbered 18 and 20 contain proprietary confidential business information regarding Gulf Power Company's fuel pricing forecasts. The information is entitled to confidential classification pursuant to § 366.093(e), Florida Statutes. Specifically, the confidential information consists of Gulf Power's internal pricing forecasts for coal, natural gas and oil through the year 2016. Disclosure of this information would negatively impact Gulf's ability to negotiate fuel pricing favorable to its customers in the future. A formal request for confidential
