Specifically, "Part A" titled Capacity Cost Recovery Calculations, page 2 of 2 of Exhibit LC-1R, contains sensitive business information concerning the number of megawatts for certain purchases or sales, the disclosure of which would enable wholesale providers to determine the prices of their competitors which would result in greater price convergence in future negotiations.


