



REQUEST FOR ORAL ARGUMENT


The Citizens of the State of Florida, through their attorney, the Public Counsel, pursuant to Rule 25-22.0022, F.A.C., hereby request the Public Service Commission to hold an Oral Argument on the issues raised in Citizens' Motion to Dismiss filed concurrently with this Request. The Citizens submits:

1. Concurrently with this Request for Oral Argument, the Citizens are filing a Motion to Dismiss the rate increase application filed by Aqua Utilities Florida, Inc. (AUF) in Docket No. 060368-WS. The Citizens base the Motion to Dismiss on the grounds that Aqua has effectively filed an entirely new case just two weeks before Intervenor testimony is due, that Aqua has failed to comply with Commission Order No. PSC-07-0592-PCO-WS, and that PSC precedent would support dismissal under the current conditions. Due to the complexity of the issues and the gravity of the request, the Commission would be well-served to avail itself of the give-and-take format of oral argument.

WHEREFORE, the Citizens of the State of Florida respectfully request that the Florida Public Service Commission hold an oral argument on the issues raised in the Citizens' Motion to Dismiss.


