Dear Ms. Drake:

You helped me with the company's CLEC docket (No. 070351-TX), which has been successfully resolved. Unfortunately, the company's IXC is in the same situation.

In the IXC case, the Regulatory Assessment Fee (RAF) return form was mailed December 15, 2006, and due by January 30, 2007. When payment was not received, a delinquent notice was sent via certified mail on February 20, 2007. The notice advised that payment must be made within 15 days of receipt of the notice to avoid an automatic \$500 fine. Our records show the notice was delivered on February 22, 2007, and signed for by Lindsay I. (I could not read the last name) (copy attached). This meant the last day to pay to avoid the automatic fine was March 9, 2007. The company's payment was postmarked April 5, 2007. This means the \$500 fine is applicable.

I wanted to give you a heads up to let you know that the Order imposing the \$500 fine against the company's IXC registration is supposed to be issued either today or Monday, August 20th. Since the fee has been paid in full, the company only owes the \$500 fine. It will have 21 days from issuance of the order to pay the fine.
