One protest from Net One International, Inc. (TX412) was received in response to Order No. PSC-07-0548-PAA-TX, issued on June 29, 2007. Consummating Order No. PSC-07-0603-CO-TX was issued on July 27, 2007, which specifically exempted Net One International, Inc. However, on August 29, 2007, the Commission received the \$1,000 fine for Net One International, Inc. Staff called the company and was advised that it had decided to just go ahead and pay the fine.

Therefore, out of the six companies associated with this docket, four companies complied with the PAA by paying the 2006 fees and fines and those CLEC certificates are to remain active. The registrations of the remaining two companies, marked with an "X" in the right-hand column (and highlighted) below, should be cancelled with an effective date of July 27, 2007.
