I am requesting permission to orally modify Item 2, Docket No. 040763-TP, dealing with the relay contract. We have continued to try to negotiate the best agreement possible after the recommendation in this docket was filed. Yesterday, Sprint filed a confidential letter committing to a lower maximum percentage increase in rates for the second contract option year. If the following changes are made to the recommendation, the recommendation will reflect acknowledging the latest confidential maximum increases. All these changes below are to reflect the latest confidential letter containing a number change.

*Pg. 2 second full paragraph, line 8, the sentence should now read " After further discussions with staff, Sprint submitted a letter on August 27, 2007, and another letter on September 6, 2007 revising its pricing cap options for years two through four of the contract period."*
