Commission Order No. PSC-07-0088-PAA-WS ordered that Sanlando Utilities Corp. provide proof within ninety (90) days of the Final Order being issued in this docket, that the adjustments to the applicable NARUC USOA Primary Accounts have been made. That Order became final on June 26, 2007 by Order No. PSC-07-0534-AS-WS, which would require Sanlando Utilities Corp. to provide proof by September 24, 2007 that the Commission ordered adjustments have been made.
